**NOTE**

1. Estimates furnished in this form shall reflect only the quantities required in addition to the original estimates, or the quantities to be deducted from the original estimates furnished in Form B.
2. Please note that supplementary estimate request will be considered incomplete if no explanation of the circumstances necessitating the increase requested, is provided in accordance with article 19, paragraph 3 of the 1961 Convention. Full explanations will greatly facilitate the prompt processing of requests to revise estimates.
3. Supporting explanations should give full detail of the medical and/or scientific basis for the revision of the annual estimates. In this connection it should be noted that while sales projections of manufacturers are helpful, they are not in any way an overriding consideration in the examination and confirmation of supplementary estimates by the Board. Explanations should be based on medical, pharmaceutical and public health considerations.
4. Quantities of narcotic drugs to be exported should not be included in estimates. Quantities for re-export in the same year can be imported without estimates under article 31, paragraph 1(b). However, if it is later envisaged that the quantities intended for re-export in the same year may remain in stock at the end of that year, stock estimates should be immediately furnished to the Board to cover such quantities or any part thereof.
5. Please provide any other information which may be useful to the Board in examining the supplementary estimates furnished on this form.
