# INCB Mission to the Bolivarian Republic of Venezuela

The International Narcotics Control Board (INCB) carried out a mission to the Bolivarian Republic of Venezuela from 8 to 11 December 2014. Dr. Lochan Naidoo, President of the INCB, was accompanied by Mr. Stefano Berterame of the INCB Secretariat.

The objective of the mission was to review the progress made by Venezuela in the implementation of the three international drug control conventions since the last mission to the country that took place in 2001.

The findings of the mission will be discussed by the Board at its 112<sup>th</sup> session to be held in February 2015 and results will be reflected in the 2015 INCB Annual Report, to be published in early 2016. Read more.

# **Key Issues and Special Topics**

All communities are affected by the illicit drug economy not just those where illicit drug crops are grown.

Chapter I of the INCB Annual Report 2005 entitled "Alternative development and legitimate livelihoods" highlights alternative development programmes as a drug control strategy to reduce or eliminate the illicit supply of drugs derived from illicitly cultivated plants. A truly comprehensive concept would include both the cultivation of alternative crops and the development of infrastructure, viable transportation and assistance in the areas of education and health care. Read more.

Over-supply, over-prescription and inappropriate or non-medical use of controlled drugs are as much of a concern to the Board as insufficient supply.

New patterns of drug abuse can easily develop as a result of excessive availability and inadequate regulatory controls. The Board expands on this subject in Chapter I of the INCB Annual Report 2000 entitled "Overconsumption of internationally controlled drugs". Read more.
