INCB facilitates provision of medicines for disaster relief in Nepal



Recent devastating earthquake that struck Nepal has resulted in an emergency situation requiring urgent shipments of medications, including medicines containing internationally controlled narcotic drugs and psychotropic substances.

The INCB would like to remind all Governments that in acute emergencies, it is possible to apply simplified control procedures for the export, transportation and provision of medicinal products containing controlled substances. In such situations, national competent authorities may permit the export of medicines containing narcotic drugs or psychotropic substances to Nepal even in the absence of the corresponding import authorizations and/or estimates. Emergency deliveries need not be included in the estimates of the receiving country.

Competent national authorities may find further information on this subject in the "Guidelines for the international provision of controlled medicines for emergency medical care" developed by WHO in cooperation with INCB.

Competent national authorities are invited to contact INCB should they require additional information or assistance in facilitating the supply of controlled substances to Nepal. Read more.

Mr. Hao and Mr. Mattick were elected by the Council from a list of individuals nominated by the World Health Organization (WHO) while the other incoming Board members were elected from a list of candidates nominated by Governments.
