# **INCB Mission to Uruguay**



INCB mission to Uruguay meets with Government officials from the National Drug Commission, Ministry of Health, Ministry of Foreign Affairs and the Institute for the Regulation and Control of Cannabis

The International Narcotics Control Board carried out a mission to Uruguay from 25 to 27 November. Mr. Werner Sipp, President of INCB, led the mission accompanied by Mr. Alejandro Mohar, Board Member, and Mr. Stefano Berterame of the INCB secretariat.

The objective of the mission was to discuss the legislation on the non-medical use of cannabis and its implementation in Uruguay.

The findings of the mission will be considered by the Board at its session in February 2016 and reported upon in the INCB Annual Report 2016, to be published in early 2017. Read more.

### **Key Issues and Special Topics**

### New INCB project to provide technical assistance to member states

INCB is implementing a new global project to provide technical assistance to member states to increase compliance with the provisions of the international drug control conventions in the regulatory control of the licit trade in narcotic drugs, psychotropic substances and precursor chemicals with the ultimate goal of facilitating the appropriate availability of internationally controlled substances for medical and scientific purposes, yet preventing their abuse and diversion to illicit channels. The project foresees, among other activities, the organization of regional workshops to deliver training to competent national authorities, as well as the development of e-learning tools. The first training workshop is scheduled to be delivered in April 2016 to countries in the Eastern Africa region.

### Recent scheduling of nine substances under the 1971 Convention

Nine substances were placed under international control under the 1971 Convention on Psychotropic Substances by the Commission on Narcotic Drugs in March 2015. The substances concerned are 25B-NBOMe (2C-B-NBOMe), 25C-NBOMe (2C-C-NBOMe) and 25I-NBOMe (2C-I-NBOMe), which were added to Schedule I of the 1971 Convention, and AM-2201, JWH-018, 3,4-methylenedioxypyrovalerone (MDPV), mephedrone (4-methylmethcathinone), methylone (beta-keto-MDMA) and N-benzylpiperazine (BZP),which were added to Schedule II of that Convention. In accordance with article 2, paragraph 7, of the 1971 Convention, those decisions of the Commission were communicated by the Secretary-General of the United Nations to all Governments, the World Health Organization and the Board on 8 May 2015, and became fully effective with respect to each party on 4 November 2015.

# Heads of National Drug Law Enforcement Agencies in Latin America and the Caribbean (HONLAC) discuss measures to curb the supply of precursors for illicit cocaine manufacture

The INCB Secretariat provided substantive guidance for a working group meeting on trafficking in cocaine and curbing access to the supply of precursor chemicals at the 25th HONLAC meeting, held in San Pedro Sula, Honduras, from 5 to 9 October 2015. The recommendations of the working group, spanning from improving public-private partnerships and cooperation between law enforcement and drug control agencies across the region, to the need for sharing of actionable information and conducting joint operations aimed at identifying the source of chemicals and their point of diversion, will be brought to the consideration of the Commission on Narcotic Drugs in March 2016. The meeting was attended by more than 70 participants from 23 countries, one intergovernmental organization and the territory of Sint Maarten (The Netherlands).
