## INCB Learning Project



The global INCB Learning Project has implemented its first regional training workshop in Nairobi, Kenya, from 24 to 29 April 2016, for countries from the East Africa region. The training brought together participants from the competent national authorities of Burundi, Comoros, Ethiopia, Kenya, Madagascar, Rwanda, Seychelles, Tanzania and Uganda at the United Nations Office at Nairobi. Additionally, observers from the Kenya Law Reform Commission (KLRC) and the African Union Commission joined the activity and contributed to the deliberations on issues related to international drug control, with a particular emphasis on the East Africa region.

The training covered topics related to the international drug control framework and INCB mandates, as well as the technical reporting requirements of the conventions relating to narcotic drugs, psychotropic substances and precursor chemicals, including on the issue of availability of narcotic drugs and psychotropic substances for medical and scientific purposes. The World Health Organization (WHO) participated during a session on the topic. Participants also gained knowledge of the use of INCB tools such as the *International Import Export System (I2ES)*, and the *Pre-Export Notification (PEN) Online system*, used by Member States to monitor international movements of narcotic drugs, psychotropic substances and precursor chemicals.

A national awareness-raising workshop for Kenya on the availability of narcotic drugs and psychotropic substances for medical and scientific purposes was also organised on 29 April 2016, with the presence of different Kenyan authorities, health care professionals and civil society groups as well as representatives from the African Union, WHO, United Nations Office on Drugs and Crime (UNODC) and the international community to discuss the importance of ensuring adequate access to medicines for pain management and the treatment of mental health conditions. The INCB 2015 Availability Report was presented at the event.

Thus far, the INCB Learning Project has been made possible through the financial contributions of the Governments of the United States of America and Australia. The next regional training workshop for national competent authorities is tentatively scheduled to take place in Bangkok, Thailand, from 11 to 15 July 2016.

#### National Control Measures on Ketamine

While ketamine is not under international control, the Commission on Narcotic Drugs, in its resolutions 49/6, 50/3 and 57/10, called upon Member States to consider controlling the use of ketamine by placing it on the list of substances controlled under their national legislation, where the domestic situation so required, and to consider adopting a system of precautionary measures for use by their government agencies to facilitate the timely detection of the diversion of ketamine.

As of 1 May 2016, information on control measures on ketamine is now available for a total of 110 countries and territories. Of these, 69 countries and territories have already introduced an import authorization requirement, and 63 countries and territories have introduced an export authorization requirement. 41 countries and territories do not require an import authorization and 47 do not require an export authorization.

The list of countries requiring an authorization for the import and export of ketamine is published in the Secure Area for Governments of the INCB website and is updated on an ongoing basis. 
### Mission to the Sultanate of Oman
